

## Student Waiver & Release of Liability

*\*A valid credit card must be on file for tuition & fees, which will be paid on an installment plan. Upon 30 days email notice to the studio any future tuition and fees will be cancelled. Paid tuition and fees are non-refundable.*

*\* Although tuition & other fees may be accepted on an installment plan, they are based on our studio year (Sep. thru June. Separate summer session) and include enrollment fee (part of first installment), tuition, costume fee, individual photo (add'l may be purchased), and recital participation (award & video).*

*\* Classes not held due to holidays, recess, rehearsals, and recitals have been accounted for in your tuition rate.*

*\*Overdue payments are subject to a late fee. Any returned check is subject to an additional \$30 bank processing fee.*

*\* Students are responsible for attending their regularly scheduled classes, We cannot offer any make-up classes or credit when a student is absent.*

*\* A re-registration fee will apply upon the return of an "Inactive Student".*

*\* Students must wear the required apparel & shoes to class and all other school functions.*

*\* Moves & Motions will not be liable for any lost or stolen personal property*

*\* We ask that students are dropped-off whenever possible; If you must stay and wait, please refrain from waiting in the reception area with infants, toddlers, or anyone that may cause a disturbance to studio activities.*

*\* Students that join a class after the session has begun may be required to take one or more private lessons in order to catch-up to the rest of their class. Although recital participation is not required, it is encouraged. The Dance rehearsals & recitals are held at a nearby High School or College Theater. The Rehearsal may be attended and viewed by one parent/guardian. The Recital is usually held during the first half of June; admission will be by reserved seating only, ticket sales will be processed online, several weeks before the event date.*
